Sri Lanka has received financing from the International Fund for Agricultural Development (IFAD) and intends to apply a portion of the proceeds toward the **supply, delivery, and installation of drip irrigation systems, polythene mulch, plastic crates, and hybrid chili seeds** to support **climate-resilient chili cultivation** under the **Smallholder Agribusiness and Resilience Project (SARP)**, implemented in the **Kurunegala, Puttalam, Vavuniya, and Anuradhapura Districts** for selected beneficiaries
2. The SARP Project invites sealed bids from eligible and qualified bidders for the supply, delivery, and installation of the items needed for the chili cultivation Projects. 3. This IFB is open to all eligible bidders who wish to respond and subject to restrictions noted in the bidding document. Further, interested eligible bidders may obtain more information from procurement division of SARP and also inspect the bidding document free of charge at the address given below in office hours at 9.00 am to 3.00 pm.

Bidding will be conducted using the **National Competitive Bidding (NCB)** method, the evaluation procedure for which is described in the bidding document, in accordance with the IFAD Procurement Handbook which is provided at www.ifad.org/project-procurement. The NCB process, as described, will include a review and verification of qualifications and past performance, including a reference check, prior to the contract award.
5. Please note that a pre-bid meeting/conference will be held on 05th December 2025 at. 10.00 a.m.at the address below, as described in the bid data sheet (BDS), Section III of the bidding document.

6. Bidders interested in submitting a bid, shall purchase the bidding document against payment of a **non-refundable fee of Rs. 6,500/= on or before 12th December 2025.**
7. Bidding documents can be obtained by sending an e-mail or letter, giving full contact details of the bidder, to the address given below. **The method of payment will be cash/bank transaction in favor of Secretary, Smallholder Agribusiness and Resilience Project, Ministry of Agriculture, Acc no. 7040662, BOC, Battaramulla branch.**
