1. Sri Lanka has received financing from the International Fund for Agricultural Development (IFAD) and intends to apply a portion of the proceeds toward the **supply, delivery, and installation of blade type sprinkler irrigation systems**, to support **grain legumes and oil crops cultivation** under the **Smallholder Agribusiness and Resilience Project (SARP)**, implemented in the **Kurunegala, Puttalam, Anuradhapura, Vavuniya and Mannar Districts** for selected beneficiaries
2. The SARP Project invites sealed bids from eligible and qualified bidders for the supply, delivery, and installation of the blade type sprinkler irrigation systems for the oil crops cultivation. 3. This IFB is open to all eligible bidders who wish to respond and subject to restrictions noted in the bidding document. Further, interested eligible bidders may obtain more information from procurement division of SARP and also inspect the bidding document free of charge at the address given below in office hours at 9.00 am to 3.00 pm.

Bidding will be conducted using the **National Competitive Bidding (NCB)** method, the evaluation procedure for which is described in the bidding document, in accordance with the IFAD Procurement Handbook which is provided at [www.ifad.org/project-procurement](http://www.ifad.org/project-procurement). The NCB process, as described, will include a review and verification of qualifications and past performance, including a reference check, prior to the contract award.
5. Bidders interested in submitting a bid, shall purchase the bidding document against payment of a **non-refundable fee of Rs. 20,000/=**.
6. Bidding documents can be obtained by sending an e-mail or letter, giving full contact details of the bidder, to the address given below. **The method of payment will be cash/bank transaction in favor of Secretary, Smallholder Agribusiness and Resilience Project, Ministry of Agriculture, Acc no. 7040662, BOC, Battaramulla branch.**
7. **Bids shall be delivered** to the address specified in the Bidding Data Sheet, Clause 23.1 of the Instructions to Bidders, **on or before 11:00 a.m. on 12<sup>th</sup> March 2026 and will be opened at 11:15 a.m. on the same day.** Please note that electronic submissions will not be accepted.
8. Bidders shall be aware that late bids will not be accepted under any circumstance and will be returned unopened at the written request and cost of the bidder. All bids must be accompanied by a bid-security as stated above table and detail in the bid data sheet.
